

Report from Fifth General Assembly in Vietnam

ISME held its Fifth General Assembly in August 2002 in Ho Chi Minh City, Vietnam, with participation of representatives of Ho Chi Minh City, local universities, research institutes, NGOs and members of ISME gathering from eight different countries.

At the opening ceremony, Mr. Nguyen Khae Ngan, the Director of Department of Agriculture and Rural Development of Ho Chi Minh City, congratulated achievements of ISME, and expressed his wishes for active discussion leading to good action plans of restoration, management, and conservation of mangrove ecosystems. Prof. Aprilani Soegiarto, President of ISME, welcomed the participants and thanked the government of HCMC and representatives of MERD for hosting the Assembly and series of ISME meetings taking place in Vietnam. Dr. Shigeyuki Baba, the Executive Secretary, thanked the participants for their supports to the activities of ISME, and Dr. Diop, Vice-President of ISME, gave a keynote address, "Future scenario on world mangrove conservation and sustainable utilization."

According to the Statutes of ISME, the election of ISME Executive Committee Members, except for the position of Executive Secretary, takes place once every three years. As reported in the recent issue of ISME Newsletter (No. 25, July 2002,) the willingness of the present executive members to continue their tenure for another three years were supported by the members of ISME. Accordingly, the participants of the General Assembly officially ratified the second term of present Executives from 2002 to 2005. Names of the Executives are as follows:

- President: Prof. Aprilani Soegiarto, Indonesia (Former Chairman of Plant Resources of South-East Asia, Indonesian Institute of Sciences – LIPI);
- Vice-President: Ambassador Noboru Nakahira, Japan (Former Ambassador to the United Arab Emirates, Malaysia, and Canada);
- Vice-President: Dr. Marc Steyaert, France (Former Director of the Division of Marine Sciences, UNESCO);
- Vice-President: Dr. E. S. Diop, Senegal (Senior Environmental Affairs Officer, Division of Environmental Information, Assessment and Early Warning, UNEP)
- Treasurer: Prof. Sanit Aksornkoe, Thailand (Professor Emeritus, Department of Silviculture, Faculty of Forestry, Kasetsart University)

Activities and finance of the past three years were reported by the Treasurer and the Executive Secretary. The activities and budget for 2002-2005, and fund raising strategies were also discussed. The following is some of the major activities ratified at the General Assembly:

- Expansion and improvement of GLOMIS (Global Mangrove Database and Information Systems);
- Continuation of the training course "Sustainable management of mangrove ecosystems;"
- Revision of World Mangrove Atlas;
- Restoration of mangrove ecosystems in Asia and Pacific;
- Planting and producing mangrove nurseries in small island countries;

In conjunction with the General Assembly, also held were several meetings of ISME, including project workshops on GLOMIS, ISME Action Plan on sustainable mangrove management, as well as meetings of Councils, Executive Committee, and so on.

The Sixth General Assembly will be held in 2005, venue of which would be Malaysia or Philippines.
